## General Rules and Regulations

1. Any member of an organized youth group in **Missouri within 100 miles of Sarcoxie.**
2. Proper exhibitor conduct is necessary for the continued success of our show. Failure to conduct yourselves as ladies and/or gentlemen could result in expulsion from the show.
3. Pre-entry of all livestock is required (see entry form at the end of the fair book)  
**ALL entries including peewee must be pre entered by August 30, 2025.**
4. All animals must be in place by **10:00 p.m. on Friday**. Animals may be brought in Thursday night, but it will be the responsibility of the exhibitor. No supervision will be on the grounds Thursday night.
5. Release time for livestock after the awards ceremony **on Saturday**. No entry may leave prior to release time unless special permission is received from show superintendent. No trailers moved until superintendent gives permission.
6. Any exhibitor that has their livestock penned in the concrete area is responsible for cleaning those pens and placing the bedding in the center cattle aisle of the barn to facilitate cleanup **NO EXCEPTIONS!!!**
7. The Chief Sarcoxie Days Fair Board reserves the right to limit the number of entries per exhibitor.
8. **No parking of vehicles or trailers in the street on the north or east side of the fair barn during the show on Saturday**
9. **Premiums will be forfeited if exhibitor leaves early without superintendent approval.**

# ***REMINDER OF RULES***

1. **NO LATE** entries accepted
2. All Aisles **MUST** stay clean and open
3. Exhibitor must be 8 years old in order to show in competitive classes
4. All livestock must be shown by the owner, or with the assistance of one other Junior except when owner is ill or in the Armed Forces in which case the animal may be shown by another Junior.
5. Adults will not be permitted in the show ring assisting with the showing of any animals. Only ring help.
6. **MUST** show **OWN** animal in showmanship classes unless specified by the judge.
7. For species that are in Round Robin; in order to be eligible for showmanship, **MUST** be present for Round Robin Showmanship following sheep show
8. Release time, no trailers moved until superintendent gives permission.
9. **Parking is tight so use your discretion as to where you park. Arena available if not too wet.**
10. **No dogs in or around the barn.**

## **Animal Livestock Regulations**

In addition to rules and regulations that may be listed in the front of this book under General Rules, the following rules and regulations will apply to livestock and other animal entries.

All exhibitors are limited to exhibiting not more than two animals in any one dairy, beef, sheep, swine, or dairy goat, meat goat class.

Each livestock exhibitor will be required to show their **own** animal in the showmanship contest unless instructed otherwise by the Judge or Superintendent. Prior entry for all livestock and dairy animals shall be required in the show. Exhibit space will be according to division entries. Stall space will be assigned by show committee.

All exhibitors of livestock must furnish his/her own feed, feed pans and watering equipment. Bedding will be provided **if available**. All livestock must be shown by the owner, or with the assistance of one other Junior except when owner is ill or in the Armed Forces, in which case the animal may be shown by another Junior. Adults will not be permitted in the show ring assisting with the showing of any animals.

Grade and Purebred animals will be shown in the same classes.

## **Animal Health Requirements for Exhibition – 2025**

### **Health Certificates**

Will follow most current animal health requirements.

A certificate of veterinary inspection (CVI) must accompany all animals to be exhibited unless specifically exempted. The CVI shall state that the animal is free of visible signs of contagious, infectious, or communicable disease, and describe the animal by species, breed, official identification (scrapies or 840 tag), sex and age. The certificate of veterinary inspection shall reflect all data for required test and vaccinations, all dates, results. The CVI is valid for thirty (30) days. Animals with active lesions of ringworm/wool fungus with resulting loss of hair or warts easily visible without close examination will not be permitted to exhibit and shall be subject to isolation or expulsion depending upon the nature and seriousness of the disease. Warts are benign, hairless, self limiting virus-induced tumors of the skin which are transmitted by direct or indirect contact. If all warts are surgically removed and the skin area is healing and dry, the animal would be allowed to exhibit.

Ringworm/wool fungus is an infectious skin disease of animals caused by various fungi and characterized by round to irregular circumscribed white powdery scabby lesions with resulting loss of hair at the lesion site. Ringworm/wool fungus also is transmitted by direct to indirect contact. Active ringworm/wool fungus will be taken home. Exhibition requirements in the state of Missouri • **Cattle** in Missouri moving for exhibition only in MO: A certificate of veterinary inspection (CVI) is required. All cattle must be free of clinical signs of infectious or contagious disease. Brucellosis – No test or vaccination is required. Tuberculosis – No test is required. Beef and dairy cattle must be officially identified prior to exhibition (strictly enforced in 2025).

• **Swine** in Missouri moving for exhibition only in MO: Must be free of clinical signs of infectious or contagious disease. A certificate of veterinary inspection (CVI) is required. All swine must be individually identified by official ear tag as defined by official identification, or ear notch, tattoo, or any other means of permanent identification. Beginning 2025, ear notch forms will not be a means of ID. Brucellosis – No test required. Pseudorabies – No test required. More info on tagging for cattle/swine: <https://agriculture.mo.gov/animals/pdf/tagging-requirements.pdf> FAQ on rules change: <https://agriculture.mo.gov/animals/pdf/exhibition-rule-change-faq.pdf> , • **Sheep** in Missouri moving within MO for exhibition only must be free of symptoms of infectious or contagious diseases. All sheep, regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification or any other means of permanent identification approved by the state veterinarian identifying them to the flock of origin and be listed on a Certificate of Veterinary Inspection (CVI). No tests are required. Scabies - sheep from a scabies quarantined area must be dipped or treated by an officially approved method within ten (10) days prior to exhibition. • **Goats** in Missouri moving for exhibition only in MO. All goats, regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification or any other means of permanent identification approved by the state veterinarian identifying them to the herd of origin and listed on a certificate of veterinary inspection CVI. No test is required. • **Poultry** and waterfowl in Missouri moving within MO for exhibition only must be free of clinical signs of contagious or infectious disease. No certificate of veterinary inspection (CVI) is required. Pullorum-Typhoid test. All poultry (except Missouri origin waterfowl) exhibited shall be tested negative for pullorum typhoid within ninety (90) days prior to exhibition or originate from a flock approved by the National Poultry Improvement Plan (NPIP) or an equivalent program which has been tested within the past twelve (12) months with no change of ownership. This information shall be documented on a VS Form 9-2 or similar certificate which shall accompany the poultry to the exhibition and shall be made available upon request. The management reserves the right to amend or add to these rules, with previous notice, as it, in its judgment, may deem advisable. Any person who violates any of the foregoing or special rules will forfeit all privileges and premiums.
